EXECUTIVE DIRECTOR REPORT FOR 2022 ANNUAL REPORT

2022 may have been the second full year of COVID-19, but in my mind the pandemic ended sometime in those 12 months. The disease continues to morph into new variants, people are still getting sick (although symptoms are much milder) and some folks are still wearing masks. While it's still a bit of a thorn in our sides, we're living with it and refusing to let it get us down.

We continue to adapt and carry on. Which is what we do in the church. If 2020 was the shock and awe and 2021 was the effort to find a new normal, then 2022 was the year we found it. Sort of. I'm pleased to report that for the first time since January 2020, I was able to hit the road and meet with people. In October, I journeyed to Parry Sound to bring the Word and the Renewal message to the wonderful people of St. Andrew's – a congregation with a long and deep association with RF. The day before, I took part in the fall gathering of Dunamis Fellowship Canada as a new member of the board of directors. More on that below.

The highlight of 2022 was our first PCC Pastor's Retreat, presented in partnership with Vaughan Community Church and support from Presbyterians Standing for Apostolic Love and Truth (PSALT). A total of 45 pastors and presenters gathered at Queen of Apostles Renewal Centre in Mississauga from Nov. 7-9. We renewed old friendships and made new ones. For many, it was the first in-person gathering (beyond session and presbytery) since the pandemic shut us down. We were blessed to be able to spend the better part of three days together in a quiet setting. The invitation went out with the Lord's invitation from Matthew 11:28-30.

"Are you tired? Worn out? Burned out . . .?" The Lord says: "Come to me. Get away with me and you'll recover your life. I'll show you how to take a real rest. Walk with me and work with me—watch how I do it. Learn the unforced rhythms of grace. I won't lay anything heavy or ill-fitting on you. Keep company with me and you'll learn to live freely and lightly." – The Message translation

Everyone brought somewhat different needs. We all experienced the retreat in a unique way. For me, it was a time to be reminded what a truly emotionally healthy life looks like. It's OK to be in touch with our emotions – our TRUE emotions, not the ones we want others to see. The idea for the retreat came from VCC leadership. (These are the same faithful folks who planned and financed the 2019 PCC Pastor Retreat in the Dominican Republic and partnered with RF on our fall 2021 virtual gathering. The 2022 retreat came together incredibly quickly over the summer and we filled all places within days. Funds from VCC, RF, PSALT and several generous supporters meant that we were able to offer the retreat free of charge and provide a travel subsidy for those coming from more than 500 km away. It was three days and two evenings of inspiration, peace, and encouragement. A full report on the retreat – told in the words of the participants – was published in the winter 2023 Renewal News and can be found at renewal-fellowship.ca. With continuing support from VCC, we are planning the second PCC Pastor Retreat this November.

Renewal Cafe – our monthly relaxed conversations via Zoom – continued. We hosted seven gatherings, each with a different conversation starter. A total of 40 individuals showed up at least once during the year. We strive to meet on the first Thursday of the month – but circumstances don't always allow it so all we were able to get in were seven. The Cafe began in the midst of COVID-19 as an effort to provide community – and we've just carried on. Further proof that good things can happen out of adversity. Another highlight was the Pray for GA campaign leading up to General Assembly, which culminated in a Zoom prayer room to monitor the proceedings while staying in touch with commissioners during every sederunt. A key part of this was pre-sederunt prayer for commissioners and post-sederunt debriefing. This was a continuation of what we had been doing in person at previous GA's.

Blogging continued as the Holy Spirit moved me. We are a voice not only of encouragement but we also advocate for change. Case in point were the revisions to Calling a Minister guidelines published in the fall which added a disturbing new section: the advice from denominational offices to presbyteries was not to appoint as interim moderators anyone who has shown "discriminatory behaviour" towards the LGBTQI+ communities. The definition of discriminatory behaviour would be up to presbytery. Taken as Gospel, some presbyteries might think anyone who holds to traditional, Biblical standards would no longer be qualified to be an interim mod. It would have marginalized those who adhere to theological orthodoxy. I immediately started asking questions of the clerks of assembly and the Life and Mission Agency. The board talked and I shared our concerns publicly. I am pleased to report that as a result of our critiques and other observers that the offending section was removed and replaced with guidelines that focused on behaviour of interim moderators rather than their personal convictions.

Back to Dunamis. These folks are cut from the theological cloth as Renewal Fellowship. The difference is that they're a tad more in touch with the Holy Spirit. DFC is part of Presbyterian-Reformed Ministries International, whose mission is to proclaim the person and work of the Holy Spirit. With the blessing of the RF board, I accepted an invitation to become an active part of Dunamis, which is actively seeking to establish partnerships with other evangelical renewal groups. DFC is comprised mostly of Presbyterians and Christian Reformed folks anyway, so it's a natural fit. Stay tuned.

And there were the routine things, which were by no means tedious.

- Our Renewal Day and annual general meeting was again held online. We were graced with teaching from Rev. Dr. Stephen Farris.
- Continued collaboration with webmaster Robin Ross as we kept the website as fresh as possible.

- I facilitated our monthly director prayer gatherings, which take place on the first Saturday of most months.
- Producing the quarterly newsletter, with wise guidance and contributions from directors Glynis Faith and Lisa Baker.

As the new year unfolds, there's renewed hope that I will be able to hit the road again. My priority will be to support a prayer room at GA and seek to make commissioners aware of the Renewal Fellowship. The other 60 percent of my call:

Congregation. By the grace of God, we continue to experience modest growth. I continue to preach through entire books/letters, verse by verse, which is a blessing. After accumulating the maximum 10 weeks of study leave, I realized I needed to use it or lose it. I've started on a Master of Pastoral Studies degree, taking two courses in the fall and two more in the winter 2023 semester. My plan is to seek certification as a psychotherapist. I'm fast-tracking as much as I can handle and God is making it happen. I hope to finish up in a year and half.

Presbytery. At the end of November, I ended my time as interim moderator at Lakeshore St. Andrew's. I continue as interim mod at Mt. Zion Ridgetown. I continued as convenor of presbytery's Administration Committee. Leamington, a once-vibrant congregation, closed. But the good news is that a group of believers purchased it and plan to reopen it as a new faith community. Presbytery's share of the sale price is more than \$900,000. My hope is that this will be reinvested in new ministry initiatives.

The home front. We said farewell to our oldest dog. But we welcomed a kitten.

God is good – all the time. All the time – God is good.

RENEWAL FELLOWSHIP WEBSITE REPORT for 2022

The continuing purpose of the Renewal Fellowship website is to advance the cause of God and the Renewal Fellowship online as efficiently and effectively as possible. Andy Cornell continues to be very active in promoting the prayer and care work of the Fellowship during this year following the momentous decisions of the General Assembly this past June. During the year, approximately 26 mailings were sent out to our 877 email subscribers during the year (down from 925), which either presented or linked to Andy's Blogs, Renewal News, Renewal Day, Renewal Café, Prayer Calendar Requests, Pray For GA 2022, "Called Together" – A Time of Encouragement, and "Come to Me" Pastors Retreat. Maintaining the *renewal-fellowship.ca* website called for the creation or updating of 44 webpages during the year.

Sadly, ever since the direction of the General Assembly on marriage and ordination was settled, interest

in our website has waned. Here are some historical statistics:

During 2019, 12,718 visitors generated 37,605 views of our website pages.

During 2020, 16,830 visitors generated 50,752 views of our website pages.

During 2021, 15,881 visitors generated 42,108 views of our website pages.

During 2022, 10,864 visitors generated 24,316 views of our website pages.

On the positive side, our website has 512 pages, presenting articles of enduring quality ranging back to the days of *Channels* magazine from 1996 on. Readers from all over the world find our website, many through search engines, from such countries as the United Kingdom, Singapore, Netherlands, South Africa, India, Nigeria, Kenya, and Germany, besides the United States and Canada. The runaway bestviewed page year after year continues to be Eugene Peterson's article, *Generosity: David at the Brook Besor*.

I consider it a great privilege to be involved in the Internet presence of the Renewal Fellowship. I am always open to considering new ideas for ways to use technology to advance the kingdom of God.

REPORT OF THE PRAYER CO-ORDINATOR FOR 2022 ANNUAL REPORT

During 2022 approximately 165 households and 376 churches received printed versions of the Prayer Calendar quarterly. Many more received the prayer calendar by email: 252 daily, 86 weekly and 552 monthly and many are seeing the Facebook Prayers daily. That's a lot of people praying for our denomination and our world and thanking the Lord for His many blessings. Some of our prayers are also included on the PresbyCan Daily Devotional which adds to our count.

I appreciate the prayer submissions I have received from coast-to-coast over the last year. We are a national church. I believe it is important that prayers for specific needs for congregations and presbyteries are included; and for that to happen, I need members of the *Renewal Fellowship* from across Canada to send me prayer requests. The requests need to be short, specific and dated, if possible. If needs arise after the prayer calendar is printed, it is still possible to have them included in the email version of the prayer calendar thanks to the faithful and quick work of webmaster Robin Ross. Please look at your church calendars and send your prayer requests to me; and more importantly, PRAY morning and evening for our church. Pray that God would give our leaders and our people great wisdom in these days. Pray that we will love God and love people. Pray that we will have eyes to see how the Lord wants us to serve our communities and our world in the coming year, even in the midst of many changes and challenges. "Praise the Lord in the deepest valley. Praise the Lord on the highest hill."

The best way to send prayer requests to me is by email, but they can also be sent by regular mail to my home address (see below). To ensure your prayer submissions are included in the quarterly printed Prayer Calendar, they must be sent 4 weeks prior to publication. The deadline for the 3rd quarter of

2023 is June 4th.
