If you have automatic debits to your bank account for such things as mortgage and utility bills payments, then you are using the concept of PAR, Pre-Authorized Remittance.

More and more churches and mission agencies are using PAR as a system of convenient monthly giving for their members and supporters. It is a simple and easy way for you to take care of your financial commitment to the work of the Renewal Fellowship, wherever you are throughout the year.

Your account will be debited on the 20th of every month and the bank account of the Renewal Fellowship will be credited with the amount payable from all supporters who participate in this plan.

A small service fee for each transaction will be paid for by the Renewal Fellowship so that you can be credited for the full amount of your donation for income tax purposes. A tax receipt will be issued by the Renewal Fellowship and mailed to you at tax time each year.

Since one of the basic purposes of the program is to ensure consistent support of the ministry, the more people in the program the more valuable and worthwhile it is to our work.

We appreciate you working with us in this way so the important witness we have may continue strong.

HOW TO GET INVOLVED

1. Decide on the amount of your monthly offering.
2. Fill in this Authorization Form and attach a sample cheque from your account marked 'sample' or 'void'.
